CIVHC and the CO APCD are recommended by the Blue Ribbon Commission for Health Care Reform in their final report to the General Assembly.

February 2008

CIVHC created through Executive Order of the Governor as a public-private partnership with the Department of Health Care Policy and Financing (HCPF).

May 2010

Colorado HB 10-1330 signed into law establishing the CO APCD; CIVHC Advisory Board established by Executive Order.


