Public Reporting Update – Cari Frank

- Moving forward, Maria de Jesus Diaz-Perez will be the point of contact for all CIVHC Public Reporting and will be distributing Data Bytes and Spot Analysis for consideration. (Cari is staying with CIVHC, just handing off these duties to Maria.)

- Publication of facility cost and quality information anticipated in summer 2018, imaging procedures first with surgical and preventive procedures to come later in 2018.

CIVHC and the CO APCD in 2018 Legislation – Kristin Paulson

- CIVHC is working with Michael Best Strategies to conduct outreach to members of the Colorado General Assembly with the goal to position CIVHC to be a source of data to inform policy development on both sides of the aisle.
 - o In the 2018 legislative session, CIVHC produced four reports in response to legislative requests
 - What is the psychoactive Rx rate for foster care children vs other children?
 - What is the difference between charge rates, discount rates, and negotiated rates?
 - How much would it cost to pay for PT in lieu of opiates for certain people?
 - What is the average amount billed vs average amount paid for different CPT codes?

State/Federal Funding – Ana English

- 50/50 maintenance funds are part of the CMS Medicaid 90/10 Federal matching program.
 - o 100% match for dollars supporting state Medicaid health information infrastructure including APCDs.
- Funding for the CO APCD written in to State budget for FY19 and signed into law by Governor Hickenlooper.
- CIVHC and HCPF are currently in the midst of several rounds of questions from the regional and national offices of the Centers for Medicare & Medicaid Services.
- Approval of the matching funds anticipated soon.
- Funds will support:
 - \circ $\,$ Ongoing operations of the CO APCD, specific to Medicaid data/analytics $\,$
 - CIVHC's ability to assist state agencies and legislators, including HCPF
 - o Unfunded public reporting mandate

Proposed Changes to CO APCD Rule – Jonathan Mathieu

- Alternative Payment Models (APM)
 - Information on APMs being employed outside of the traditional fee-for-service model will contribute to a more complete understanding of the total amount spent on health care for Coloradans and will allow the state to set goals, understand best practices, formulate strategies and track progress toward providing high value care.
- Prescription Drug Rebate Information
 - Aggregate information regarding prescription drug rebates (collected in accordance with Federal laws) will help Colorado better understand how much is being paid for prescriptions drugs, track trends, and identify opportunities to reduce spending.
- Medicare Beneficiary Identifier
 - Beginning in 2018, Centers for Medicare & Medicaid (CMS) transitioned to a new patient identifier called a Medicare Beneficiary Identifier (MBI). Submission of the new MBI number will enable CIVHC to update the CO APCD data warehouse and continue to report meaningful information for the Medicare population.
- **COMMITTEE MOTION:** The Committee passed a motion to submit a letter of support regarding the proposed Rule changes to Executive Director Bimestefer. The Committee reviewed and discussed the letter prior to the motion by Bob Smith. The motion was seconded by Donna Baros and passed unanimously.

Administration of HCPF/CO APCD Scholarship – Peter Sheehan

- HCPF provides up to \$500,000 in annual grant funding to defray the costs of non-profits and government entity access to the CO APCD for research.

- Newly passed, HB 1327 calls for the CO APCD Advisory Committee to have a role in reviewing and recommending applications for scholarship grants.
- CIVHC is working to set up conversations with HCPF to discuss how to structure the Committee's role in the new Scholarship approval process.
 - Pete Sheehan is the lead on this effort and will be in communication with the Committee and information become available.
 - It is anticipated that the procedure will need to be in place and operational by July 1, 2018.

- George Swan, former hospital CEO and interested constituent, expressed his interest in having downloadable CO APCD data on the CIVHC website. He also discussed his desire for Colorado to have a data portal that compiles data from many sources and that allows users to download various data sets into Excel files in order to facilitate analysis via pivot tables. He showed the Committee the website he constructed on Google sites and voiced his hope that CIVHC (or a similar entity) would ultimately assume control of the site.
